

Black Friday Gift Voucher Terms and Conditions

1. Arena Racing Company (“**ARC**”) hereby provides customers with the chance to purchase a gift voucher as detailed below (each a “**Gift Voucher**”):
 - a. £80 gift voucher - £20 on top for free;
 - b. £45 gift voucher - £10 on top for free;
 - c. £28 gift voucher - £7 on top for free;
 - d. £17 gift voucher - £3 on top for free.
2. To be eligible for purchasing a Gift Voucher, customers must be aged 18 or over.
3. Upon a successful purchase of a Gift Voucher, the customer shall receive a code (“**Code**”) to the email address supplied during the purchasing process.
4. Gift Vouchers can only be used for advertised ticket and hospitality packages.
5. Gift Vouchers cannot be used to purchase annual memberships, any “*The Winning Deal*” packages, other gift vouchers, non-racing, third-party events, bookmaker tickets or tote.
6. Gift Vouchers cannot be redeemed against ticket or hospitality packages that total more than £500 at any one fixture when booking as an individual or as a group.
7. Gift Vouchers may be redeemed against general admission tickets, restaurant and hospitality bookings at the following greyhound tracks: Central Park, Dunstall Park, Nottingham, Newcastle and Sunderland (each a “**Track**”).
8. Gift Vouchers can only be redeemed online by providing the Code received following purchase. Gift Vouchers cannot be redeemed in-person at the Track.
9. Gift Vouchers may only be purchased from 27 November 2025 until 23:59 of 1 December 2025 and can only be used to purchase tickets or hospitality during 2026 fixtures at the Tracks.
10. Gift Vouchers are non-refundable, non-transferable and have no cash alternative.
11. Gift Vouchers cannot be used in conjunction with any other offer/discount/promotion.
12. Any unused/partially used Gift Voucher will expire on 31 December 2026.
